- Remaining  $\frac{1}{6}$  member of legislative council by directed (Nominated) elected [By (G)]
- >  $\frac{1}{3}$  Of its member retire on expiration of every 2 year.
- > Vacant seats are filled by fresh election & nominated by governor at beginning of every 3 year.
- ▶ Retiring member are also eligible for election & re nomination any no. of times
- Eligibility age of LC is 30

#### **Disqualification of any Member**

- decision of Speaker of LA final regarding to 10<sup>th</sup> schedule Anti defection law
- decision of Chairman of LC final regarding to 10<sup>th</sup> schedule Anti defection law
- Speaker of LA is final but under "Judicial Review".
- > If a member absent for 60 days without its permission, membership will be ceased.
- > Presiding officer of LA Speaker & Depty speaker.
- > Presiding officer of LC Chairman & Depty chairman.
- Speaker can resign by writing to depty speaker

#### **Power of Speaker**

- ➤ He is final interprets of provision of
  - Rules of Procedure & conduct of Business of Assembly
  - Legislative precedents
- Secrete meeting
- Casting vote in case of tie.
- Decide bill is Money Bill or not.
- ▶ Disqualification of member 10<sup>th</sup> Schedule
- ➢ He is chairman of
  - All committees of Assembly & supervise their functions in LA
  - Himself chairman of Business Advisory Committee& Rule Committee, General Purpose committee in LA

#### Note

- ▶ If speaker & depty speaker absent speaker nominate from amongst the panel member
- Salaries & allowance of chairman & speaker fixed by SL & they are charged on the consolidation fund of state. There are not subject to annual vote of state legislature.
- LA usually time 5 year, After 5 year It automatically dissolved but LA period can be extension 1 year (any time) during national emergency. But re election of (LA) should be After 6 months revoke of emergency.
- > In LC, It is permanent body. Their chairman elected from member of LC.

#### **Session of State legislature**

#### > Summoning

- Max gap '6 months' 2 times meet per year
- Governor from time to time summons each house of SL to meet.
- > Adjournment

- Suspend the work for hour, days, weak.
- Adjournment sine die means terminating a sitting of SL for an indefinite period.
- Both powers reside with speaker.
- > Prorogation
  - Adjourn Sine die declare session is computed within net few days. govt issue a notification for prorogation of same. It terminates the session.

#### > On Dissolution

- On direction of LA Lapsing the bill
- Bill pending in Assembly lapses
- Bill passed by assembly but pending in council lapse.
- A bill pending in council but both house pending are not of Governor or President, not lapse.
- A bill passed by both return by President Not lapse.
- > Quantum
  - 1/10 of total member
- Casting vote
  - Speaker not allowed to vote in Parliament, but in case of tie he can vote
- Language in SL
  - The SL is authorized to decide, whether to continue or discontinue English as a flour language of computing of 15 year from commencement of
- > A minister can participate in proceeding of house of which he is not a member.
- > A minister who not member of any house can participate in proceeding of both houses.
- > If bill a passed by (LA) & send to (LC) then in Ist time (LC) delay 8 months
- Again bill passed by (LA) & send to (LC) then IInd time (LC) and delay 1 month of that bill deemed to passed total 4 months (LC) can delay the bill
- No joint provision at state level
- But joint provision at centre level Lok sabha, Raj Sabha
- > Money Bill
  - Can't introduced in LC, only in LA, on the recommendation of Governor
  - LC have to return money till to LA within 14 days
  - If the pill reserve recommendation from Govt. to President, the in this case president can't return money bill to state legislature.
- Max delay in Bill 4 months (3 month in first time and 1 in second time)
- No joint sitting at state level
