PAPER - I

INDIAN HERITAGE AND CULTURE, HISTORY AND GEOGRAPHY OF THE WORLD AND SOCIETY

- ➤ Indian culture will cover the salient aspects of Art Forms, Literature and Architecture from ancient to modern times.
- Modern Indian history from about the middle of the 18th century until the present significant events, personalities and issues.
- ➤ The freedom struggle its various stages and important contributors/ contributions from different parts of the country.
- ➤ Post independence consolidation and reorganisation within the country.
- ➤ History of the world will include events from 18th century such as industrial revolution, world wars, redrawal of national boundaries, colonization, decolonisation, political philosophies like communism, socialism etc their forms and effect on the society.
- > Salient features of Indian Society, Diversity of India.
- ➤ Role of women and women's organisation, population and associated issues, poverty and development issues, urbanisation, their problems and their remedies.
- > Effects of globalisation on Indian society.
- > Social empowerment, communalism, regionalism and secularism.
- > Salient features of world's physical geography.
- ➤ Distribution of key natural resources across the world (including South Asia and the Indian sub continent); factors responsible for the location of primary, secondary and tertiary sector industries in various parts of the world (including India).
- ➤ Important geophysical phenomena such as Earthquakes, Tsunami, Volcanic activity, Cyclone etc geographical features and their location changes in critical geographical features (including water bodies and ice caps) and in flora and fauna and the effects of such changes.

PAPER - II

- ➤ Comparison of the Indian constitutional scheme with that of other countries.

- ➤ Parliament and State Legislature structure, functioning, conduct of business, powers and privileges and issues arising out of these.
- > Structure, organisation and functioning of the executive and the Judiciary Ministries and Departments of the Government; pressure groups and formal/informal associations and their role in the Polity.

- ➤ Appointment to various constitutional posts, powers, functions and responsibilities of various constitutional bodies.

PAPER - III

- > Inclusive growth and issues arising from it.
- > Government Budgeting.
- ➤ Major crops cropping patters in various parts of the country, different types of irrigation and irrigation systems storage, transport and marketing of agricultural produce and issues and related constraints; e technology in the aid of farmers.

- ➤ Issues related to direct and indirect farm subsidies and minimum support prices; Public Distribution System objectives, functioning, limitations, revamping; issues of buffer stocks and food security; Technology missions; economics of animal rearing.
- ➤ Food processing and related industries in India scope and significance, location, upstream and downstream requirements and supply chain management.

PAPER – IV

Questions may utilize the case study approach to determine these aspects. The following broad areas will be covered.

- ➤ Ethics and Human Interface: Essence, determinants and consequences of ethics in human actions; dimensions of ethics —in private and public relationships. Human values lessons from the lives and teachings of great leaders, reformers and administrators; role of family, society and educational institutions in inculcating values.
- Altitude: content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.
- ➤ Aptitude and foundational values for Civil Service, integrity, impartiality and non partnership, objectivity, dedication 10. Public service, empathy, tolerance and compassion towards the weaker sections.
- > Emotional intelligence concepts and their utilities and application in administration and governance
- ➤ Contributions of moral thinkers and philosophers from India and world.

- ➤ Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values in governance ethical issues in international relations and funding; corporate governance.
- ➤ Probity in Governance: Concept of public service; Philosophical basis of governance and probity; information, Codes of ethics, Codes of conduct, Citizen's charters, Work culture, Quality of service delivery, Utilisation of public funds, Challenges of corruption.
